We have audited the annexed balance sheet of the "COORDINATION OF HUMANITARIAN ASSISTANCE (CHA)" as at December 31, 2002 and the related income and expenditure account together with the notes forming part thereof (hereinafter referred to as the "financial statements") for the year then ended.

These financial statements are the responsibility of the Management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting policies used and significant estimates made by management, as well as evaluating the overall presentation of the financial statements. We believe that our audit provides a reasonable basis for our opinion.

We report that:

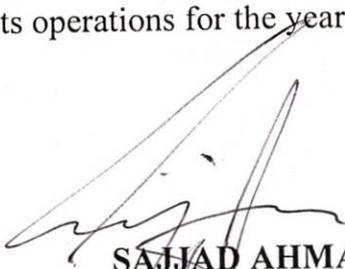
No provision has been made in the accounts in respect of Hawalas amounting to Rs 96,000 (Qandhar Field office) and USD 10,500 (Ghore field office) which are doubtful of recovery.

- (b) where funds were received for a specific stated purpose, these have been spent for that purpose only; and

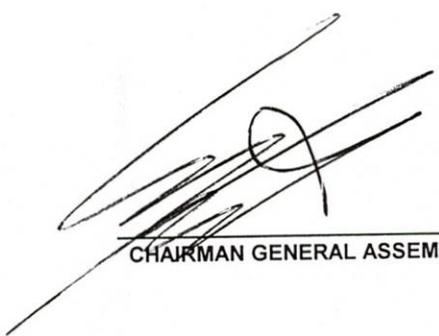

NOTES TO THE ACCOUNTS

FOR THE YEAR ENDED DECEMBER 31, 2002

1. Status of Organization

The organization was established in 1988. Its aim was to provide emergency aid for war victims in the field, to assist with the Rehabilitation of rural and urban life and to work with communities for sustainable developments in Afghanistan

2 Significant Accounting Policies

2.1 Capital Assets Written Off

The cost of fixed assets purchased during the year are being written off against the funds received from the various donors in the same period. However, the written down values of the fixed assets at the year end are disclosed in the accounts as memorandum. Depreciation is charged on the fixed assets on straight line method at the rates given in fixed assets schedule.

2.2 Stock and Stores

Stores purchased during the year for programme Offices are treated as having been consumed during the year.

2.3 Exchange Rates

Exchange Gain Realized

Funds received and expenditures incurred against such funds during the year in Afghanis and Dollars have been converted into pak rupees on the basis of open market conversion rate of US \$ into Pak rupee. As a result of such treatment no realized exchange gain is appearing in the financial Statements.

Exchange Gain Unrealized

Funds from various donors in foreign currencies mainly in US \$ are being directly received into the bank accounts maintained with different banks. The same has been incorporated into the books of accounts (system) at the conversion rate on which the Us \$ have been converted into Pak Rs in the open market and the same rate is then used for the conversion of expenditure incurred in AFGs and RS into US \$. At the year end, the balance appearing in the balance sheet items in different currencies are being converted into US \$ at the conversion rate as at 31st December and the difference so worked out at the date of balance sheet is considered as unrealized exchange gain/loss.

2.4 Revolving Loan

Funds are received from donors agencies against revolving fund loan scheme and are incorporated in the books of accounts as expenditure at the time of receipt of the funds. The amount so received against loan scheme are being incorporated as expenditure by giving the corresponding credit to the Credit Pool fund.

2.5 Donation in kind

It is the policy of CHA to not to record the donation received in kind from the donors for onward distribution to the beneficiaries. Only the expenditure incurred on the distribution is reflected in the accounts.

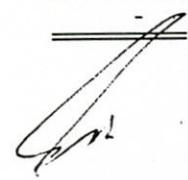
